4. Planning community dental health programs: assessing the needs of a target population, determining priorities, program goals and objectives, identifying community resources, program implementation and evaluation

6. Need and demands for dental care; utilization of dental services; barriers to the utilization of dental services; strategies to effect change in the need, demand for and utilization of dental services
