This course uses a geographical approach to examine the spatial patterns of development and analyze the numerous models and programs that have been used to ameliorate poverty. In particular, the course demonstrates how questions of scale and multiple perspectives influence the design, implementation, and outcomes of sustainable development programs. LEARNING OUTCOMES:

Upon successful completion of this course, students will be able to:

- 1) Discuss the geographical context of development and underdevelopment in both the developing South and the developed North from a multi-scalar spatial perspective.
- 2) Describe how global processes are leading to progressively unequal patterns of development and change.
- 3) Critically evaluate the implications and impacts of development methods, programs, and poverty alleviation projects.
- 4) Identify key sources for information on topics within international development geography, and how to critically utilize these sources in a research project.
- 5) Clearly convey the findings of one's research to a general audience.

The format of the course will include lectures, assigned readings, discussion groups, and oral presentations. Special emphasis will be placed on student participation in seminars, group projects, and field observation and reporting. Audio visual materials and case studies will support lecture material.
