- Make the capitalization consistent in the Course Content and Topics section.
- Under Week Four of Course Content and Topics, revise to "Stereotypes:"
- Under Week Twelve of Course Content and Topics, remove the colon.

- Revise the Texts and Resource Materials section to have consistent APA formatting.
- Make the capitalization and punctuation consistent in the Content and Topics section.
