- Under the Recommended Evaluation Methods and Weighting Details section, revise to a list rather than sentence structure. Also remove any percentages listed.
- Under Typical Instructional Methods, use consistent punctuation and capitalization across all course outlines.
- Under Typical Instructional Methods, add a space before "minilectures". Also revise end to "and written assignments."
- Under Texts and Resource Materials, revise the 4th resource to "1: Sentences..."

- Under Learning Outcomes, the template example language should be removed.
- Add a Learning Outcome that states "Explore the way we use sounds and symbols in English and global Indigenous languages.
- Under the Recommended Evaluation Methods and Weighting Details section, revise to a list rather than sentence structure.

- Under Recommended Evaluation Methods and Weighting, lab work can be fully crossed out.
- Under Typical Instructional Methods, use consistent punctuation and capitalization across all course outlines.
- Under Required Additional Supplies and Materials, revise to "and volume..."
- Under Course Content and Topics, revise to "-ed endings" for consistency.
- Under Course Content and Topics, revise to "styles: tone..."
- Recommend investigating if PLAR should be an option for all course outlines since the program residency does not allow it to be used.

- Recommend investigating if PLAR should be an option for all course outlines since the program residency does not allow it to be used.

- Under the Recommended Evaluation Methods and Weighting Details section, revise to a list rather than sentence structure. Also remove any percentages listed.
- Under Typical Instructional Methods, use consistent punctuation and capitalization across all course outlines.
- Recommend investigating if PLAR should be an option for all course outlines since the program residency does not allow it to be used.

- Under the Recommended Evaluation Methods and Weighting Details section, revise to a list rather than sentence structure. Also remove any percentages listed.
- Under Typical Instructional Methods, use consistent punctuation and capitalization across all course outlines.
- Under Course Content and Topics, remove the existing section of text broken down into weeks.
- Recommend investigating if PLAR should be an option for all course outlines since the program residency does not allow it to be used.

- Add a Learning Outcome that states "Explore Indigenous ways through oral storytelling and recognizing the land (e.g. writing territorial acknowledgements).
- Under the Recommended Evaluation Methods and Weighting Details section, revise to a list rather than sentence structure. Also remove any percentages listed.
- Under Typical Instructional Methods, use consistent punctuation and capitalization across all course outlines.
- Recommend investigating if PLAR should be an option for all course outlines since the program residency does not allow it to be used.

- Revise the Learning Outcomes to a numbered list.
- Under the Recommended Evaluation Methods and Weighting Details section, revise to a list rather than sentence structure. Also remove any percentages listed.
- Under Typical Instructional Methods, use consistent punctuation and capitalization across all course outlines.
- Under Course Content and Topics, remove the existing text broken down by module.
- Recommend investigating if PLAR should be an option for all course outlines since the program residency does not allow it to be used.

2.12. English Language Studies – Major Revisions – Helen Butner

MOTION:

That the major revisions to the English Language Studies program be accepted and recommended to ECHD Faculty Council with the following amendments:

- Throughout the document, ensure it states "associate certificate" wherever it currently states "certificate".
- Ensure links are added throughout the document, where applicable.
- Under Entrance Requirements Domestic Students 1, revise to "To apply to Adult Basic Education, students should".

- Under Entrance Requirements Domestic Students 1, revise the second bullet to "have completed a B.C. secondary school graduation or equivalent. (see the <u>Admissions section</u> of the Academic Calendar for more information on equivalents to B.C. secondary school graduation); or".
- Under How to Apply 2, revise to "be provided with registration information by email prior to courses starting."
- Under How to Apply, revise to "Domestic students (including Permanent Residents, may be referred to UFV through partner agencies, which..."
- Under How to Apply, revise to "Upgrading and University Preparation (UUP)..."
- Under the first bullet in Assessment for EAP Courses, revise to "Canadian Language Benchmark (CLBPT), Canadian Language Benchmarks Placement Assessment (CLBPA), or an official copy of a LINC Certificate with the CLB level successfully completed."
- In the table under Assessment for EAP Courses, add back the bullet point before EAP 066 and remove the extra line space between it and EAP 065.
- Under Register for EAP Courses Domestic Students 1) b., revise to "EAP 064 (a reading/writing..."
- Under Register for EAP Courses, add wording to define "successfully completed," similar to that found under Advancement in English Language Studies.
- In the table under English Language Studies Intermediate Associate Certificate, remove the 3 from the second last row of the last column.
- In the tables under all the associate certificates, ensure there is consistent capitalization and that "level" has not been accidentally deleted in the Title columns.
- Depending on the decision regarding the availability of PLAR on the course outlines, the residency requirements may need to be revised.
