## 1. WELCOME

Meeting called to order at 10:05 a.m. Rosetta welcomed everyone to the Faculty Council meeting.
Rosetta warmly welcomed Vice Provost/Associate Vice President, Dr. Peter Geller to share with Faculty Council information on indigenization within the academy and his role as Vice Provost at UFV.

## 2. GUEST SPEAKER - DR. PETER GELLER - VICE PROVOST/ASSOCIATE VICE PRESIDENT, ACADEMIC

### 2.1 Indigenization within the Institution

Dr. Peter Geller introduced indigenization within the institution with the question, "What is indigenization?" Karl Heel, Garden River Nation, describes indigenizing as feeding back to the community. Peter acknowledged that we are on traditional Stó:lō territory. We are Matsqui, Sumas and Kwantlen's closest neighbours.

Peter discussed the Métis Day Awareness Event at the Aboriginal Gathering Place, CEP on November 7, 2012. There was a great turn out of approximately 250 people; about 50 from UFV. At the event they combined traditional university styles, such as keynote speakers and facilitators with habitual Stó:lō long house traditions and rituals. Peter shared with us Karl Heel's 6-point explanation of indigenization:

1. Bring an Indigenous voice to the Academy
2. Ensure cross-cultural communication between students, faculty, and staff so everyone feels welcomed and well respected
3. Seek and implement indigenous content in courses
4. Every student graduating from post secondary institutions should have knowledge of indigenizing
5. Everyone working in post secondary institutions should have knowledge of indigenizing
6. Respect and integrate all levels on indigenizing

An event such as the Métis Day Awareness gives energy and momentum as well as encourages people to become more involved in indigenizing. The Faculty of Professional Studies is doing many good things in this aspect.

Peter appreciated Professional Studies' SPARK! Event. It advocated academic life versus personal life. Who we are comes out in the workplace. We need to be open and willing to try and to respect the traditions of the Indigenous people.

The formal acknowledgement to recognize the Indigenous people and their land is as follows:
"El Swayel. I would like to acknowledge the Traditional Stó:lō territory where we are meeting today. Here in Abbotsford I would like to particularly acknowledge the Sumas, Matsqui and Kwantlen First Nations, our closest neighbours."

### 2.2 The Role of the Vice Provost/Associate Vice President, Academic

Dr. Peter Geller works closely with Shirley Hardman, Senior Advisor on Indigenous Affairs, and Dr. Eric Davis, Provost \& Vice President, Academic. Peter is responsible for International Education, Quality Assurance, Program Development, Academic Policy, Governance Structure, Reviewing and Revising Academic Governance, Space Planning, and Faculty Relations.

## 5. NEW BUSINESS

### 5.1. Institutional Learning Outcomes

The Teaching and Learning Advisory Council came up with a year two plan for aligning the Institutional Learning Outcomes with outcomes from programs and departments. There are many upcoming seminars and workshops. Teaching and Learning sent out a "Call for Proposals: Demonstration Project." The purpose is to ask schools/departments to show-case their process, to align Program Learning Outcomes with the Institutional Learning Outcomes.

Within the Faculty of Professional Studies, ECE/CYC, TEP, and ADED will be submitting proposals. Funds are available for each project: $\$ 2000-\$ 3500$. Proposals are to be submitted by November 30, 2012 and a decision will be made by December 5, 2012.

Rosetta noted that the Field Education and Practicum Committee is a cross-faculty committee and there are members on this committee outside of the Faculty of Professional Studies. Les Stagg reported some of the topics the Field Education Committee has researched: criminal record checks, risk assessment for practicums, practicum student's WBC coverage, and insurance for out-of-province students.
