1. WELCOME/INTRODUCTIONS

Thank you to Cyrus Chaichian for chairing the meeting.

Doris Ball, Staff Representative and Colleen Bridges, TEP Education Advisor, were welcomed. Alison Kalnicki, the new Administrative Assistant for the Professional Studies' Dean's office was introduced.

2. ADOPTION OF AGENDA

On a motion duly made and seconded, the agenda was approved as presented (Moved: Ian Hunt; Seconded: Mark Breedveld).

3. APPROVAL OF MINUTES - February 19, 2010

On a motion duly made and seconded, the minutes were approved as provided (Moved: Ian Hunt; Seconded: Les Stagg).

4. CONTINUING BUSINESS

4.1. UFV Strategic Plan

Professional Studies' comments made on the Draft Strategic Plan were forwarded to the Strategic Plan Committee. Some changes were made based on the comments of all the Faculties. A revised version was forwarded to the Senate.

5. NEW BUSINESS/DISCUSSION ITEMS

5.1. Guidelines for Writing Policy

Draft guidelines from Bill Cooke were included in the meeting package. The document was read and the ensuing discussion included:

- Some UFV policies are out-of-date so draft guidelines have been drawn up.
- Clarification was received that guidelines are intended for UFV policies at the Senate and BOG level, not Departmental policies. However, the guidelines may be used for Departmental policies.
- "Primary contact" would preferably be an office as the person in that capacity changes.
- "Procedure" could include where and how documents are circulated and stored.
- A suggested addition is a statement requesting clear and concise language that avoids acronyms and jargon.
- Positive feedback was received on the structure of the draft guidelines, especially that it
 is divided into "must have" and "should have (if needed)" sections.

Professional Studies' comments will be summarized and sent to Bill Cooke.

5.2. Business Continuity Plan

Continuity Plans in case of emergencies are in place for UFV Facilities, Finance and Administration but not for the academic units.

A discussion ensued about what could be included in a Business Continuity Plan:

- A large structure may have communication difficulties in an emergency so use smaller units such as departments instead. However, clear plans need to be in place to ensure everyone is on same page.
- An overall plan needs to work with the distinct needs of all the different departments and programs i.e. Will on-site practicum students receive the educational support needed if UFV is shut down?
- It is important to have a mindset of preparedness and to make back up plans for possible situations such as earthquake, flood, on-campus shooting and power outage. Plans need to include transportation, insurance, course rescheduling, supervision, student attendance and overall safety.
- Different levels of severity can be assessed and included in the plans.
- Risk management planning could include the manager of Occupational Health and Safety and other experts. Also other similar institutions' continuity plans can be used as a model.

5.3. Reflections on Faculty Council

Feedback was received on the effectiveness of Professional Studies Faculty Council. Comments included that:

- Faculty Council provides:
 - Relationship building & camaraderie
 - Sense of belongingness
 - · An invaluable level of governance for faculty to input into where UFV is going
 - · A sharing of others' perspectives
 - · Good decision making and sub-committee work
- Faculty Council works best when:
 - · The agenda is in tune with the Senate's agenda
 - · Prior notice is sent out before the agenda is finalized
 - · There is a 3rd party chair
 - · Student representatives are able to bring items forward
- In the future, Faculty Council could:
 - · Use name labels
 - Use A421 as a location
 - · Encourage more faculty to attend i.e. pizza, a Monday-Thursday date
 - Encourage more communication between Student Representatives and the student body

6. REPORTS

6.1. Reports from Established Committees

6.1.1. Nominations and Election Committee - Lisa Moy

Terms of Reference and a Report were distributed.

Thank you to Ron Zitron for volunteering to join the Information Technology (IT) Committee. On a motion duly made and seconded, Ron Zitron's appointment as the Faculty's representative to the IT Committee was approved (Moved: Mark Breedveld; Seconded: Robert Harding).

6.1.1.1. Ratification of Terms of Reference

On a motion duly made and seconded, the draft Terms of Reference were approved as distributed (Moved: Gerry Palmer; Seconded: Don Miskiman).

6.1.2. Field Education and Practicum Placement - Christine Neigel

6.1.2.1 Ratification of Terms of Reference

After discussion it was decided that the Committee will add a "Field Education & Practicum Placements" definition to the Terms of Reference. The definition will clarify that field school and internships are included but co-op is not.

6.1.3. Retention Committee - Cindy Rammage

Minutes and Report were distributed.

Characteristics of a 1st year student's experience is a larger determining factor of ongoing success then the characteristics of the person so focus of retention committee will be on 1st year students.

The committee is waiting for results from an Institutional Research survey and a National Survey of Student Engagement (NSSE).

The committee will look into what kind of information relating to Aboriginal students is available and how to reach UFV students who are undecided about what program to follow. Rosetta clarified that other faculties are experiencing difficulties in advising due to their central advising centres as opposed to Professional Studies advisors who are program centred.

6.1.4. Learning Exchange Committee - Georgina Marsom

The Committee meets at 9am prior to the Faculty Council meetings.

6.2.1. Faculty of Science - Maple Melder Croizier

UFV is facing attrition. Ideas to encourage retention are student socials with talks, beer gardens, movie nights and having a tutor program where 3rd and 4th year students assist 1st year Science students.

The Faculty of Science is looking into a time limit on finishing a degree.

High school graduation requirements have changed this year and will change again next year. It is affecting program prerequisites and requirements.

6.3. Report from Senate - Gerry Palmer

6.3.1. Senate Standing Committees

Senate Standing Committees have been finalized by Dr. Evered and will be functioning in September 2010. The Governance Committee will be looking into a nominating process for the membership of these Senate committees. Faculty representation is at least 50% of the committee. 6.3.3 Budget

Senate concentrated on the budget a fair amount at the last meeting. Overall, the budget is limited. There will probably be no allocations for new faculty positions not already approved; increase in FTE's will need to be through retention, not new classes. A small increase to tuition has been approved.

6.4. Dean's Report

Was distributed.

The academic structure of UFV is being reviewed in terms of the effectiveness of the Faculties. UFV has the least number of faculties per capita of all similar Canadian universities. At the same time, there is no money for additional Deans.
