5.1. Rank and Tenure – Standing Item – Tracy Ryder Glass

- The deadline for expressions of interest for promotion has passed for this year.
- Maryam Siahbani has joined the Divisional Review Committee (DRC) for Business, Computing and Information Studies as a voting member. Talia Q has moved from this DRC to the University Review Committee.
- No applications were received for the DRC for Adult Education; Teacher Education; Child, Youth and Family Studies; and Social Work and Human Services. Those members who have agreed to a year extension on that DRC were thanked. The DRC will be seeking new membership this Fall and Winter.

5.2. Fall Planning Update – Tracy Ryder Glass

- The UFV Planning Principles for Return to On-Campus Academic Programming for Fall 2021 were distributed by the Provost's Office. As the start of the Guidelines share, "the Minster of advanced Education and skills Training released a public statement that based on the advice of Dr. Bonnie Henry in her letter to all Presidents (posted on our website), post secondary institutions in BC should be planning for a safe resumption of regular on-campus activities starting in the Fall of 2021...However, this does not mean that we should be returning to replicate exactly what we did in the Fall of 2019." The document goes on to share key themes of safety, access, flexibility, academic integrity, technical support, distributed leadership, and community relevant programming.
- Tracy highlighted that the choice of what and how to deliver Fall courses will fall to the program areas and Dean to determine what works best for the students, staff, and faculty in those areas. Tracy recognized that all departments and schools are actively planning the best method for their areas and, of course, a Plan B which might include pivoting to fully online.
- The next step in Fall planning is to enter course offerings into the DCU, UFV's course scheduling software. The Office of the Registrar will provide definitions of the non-traditional delivery methods like "hybrid" and "flex" as well as data-entry processes when the DCU opens.

 UFV is currently under a health authority directive to which we do not require medical documentation for an employee or student when sick. With this in place, the Attendance Policy is not followed. Should this directive not be in place, UFV and the Faculty of Professional Studies will have to consider how to accommodate those that are absent from class due to illness, whether it is COVID or not. All courses have a Blackboard shell which should be used to communicate with students what occurred in class so that they might independently get themselves caught up, similar to what has been happening in K-12 over the last school year. The Teaching and Learning Centre and Mary Saudelli are available to provide support with this.
