1. Call to Order

1.1. Approval of Agenda – May 11, 2018

2. For Recommendation to Faculty Council

2.1. BUS 377 Cooperative Enterprises – Major Revisions – *Jim Swaffield*

MOTION:

THAT the major revisions to BUS 377 Cooperative Enterprises be accepted and recommended to Faculty Council with the following amendments:

- If the course is not intended for registration from students in other programs, consider adding "admission to the Bachelor of Business program" as a prerequisite.
- In the memo, check the "6 year review" box and complete question #9.
- Revise the Typical Instructional Methods to "Lectures, discussion, guest lectures, field trips to cooperative organizations."
- Review the Typical Course Content and Topics section to make capitalization consistent throughout.

- In the memo under #2, revise the last sentence to "Therefore, the CIS Department has approved the residency for the CIS certificate to require a minimum number of 9 (nine) credits of CIS/COMP courses to be taken at UFV." Use bold text for this sentence.
- In the memo under #4, capitalize "Indigenous."
- In the memo under #6, revise the first sentence to "Students will now be required to complete a minimum number of CIS/COMP credits towards the discipline-specific credential here at UFV."

- In the memo under #4, capitalize "Indigenous."
- In the memo under #6, revise the first sentence to "Students will now be required to complete a minimum number of CIS/COMP credits towards the discipline-specific credential here at UFV."

2.5. Bachelor of Computer Information Systems – Recognition of Previously Completed CIS and COMP Courses – *Carl Janzen*

- In the calendar copy under Recognition of Previously Completed CIS/COMP Courses, capitalize "Department" throughout.
- In the calendar copy under Recognition of Previously Completed CIS/COMP Courses, correct "priot" to "prior."
- In the calendar copy under Recognition of Previously Completed CIS/COMP Courses, correct "whesterh" to "whether."
- In the calendar copy under Recognition of Previously Completed CIS/COMP Courses, revise the first sentence to "students who complete courses in other programs..."
- In the calendar copy under Recognition of Previously Completed CIS/COMP Courses, revise the end of the first sentence to "can be recognized by, or transferred to, the CIS program."
- In the calendar copy under Recognition of Previously Completed CIS/COMP Courses, revise the second bullet to "Generally, courses taken more than 10 years ago will not be considered applicable. Courses taken more recently will not be considered applicable if there has been significant change in the course subject matter or technology."
