3.1. Agriculture Technology Department Standards for Tenure and Promotion

Revised Standards were received and reviewed. Previous discussions at FSC noted points of indigenization for Agriculture to consider but they were not reflected in the previous memo to the Dean. The committee reviewed the Standards again and will provide some additional suggestions, including adding explicit examples in the criteria sections on how to Indigenize and decolonize. The FSC notes that Standards should be explicit to assist in the review process.

The University Wide Principles #4 states "Standards developed for teaching, scholarly activities, and service should be consistent with the mandate and mission of the university".

3.2 Terms of Reference review

The Chair met with the Director of Equity, Diversity, and Inclusion (EDI) regarding reviewing the Terms of Reference against an EDI lens. Some principles and procedural suggestions were given and the committee noted a few more.

The committee provided a few recommendations including additional consultation avenues. It was noted that much consultation is already in place, such as receiving feedback from the department and faculty council using a cyclical process where feedback is given and taken.

Additional feedback will be sought from the FSC by email with a final discussion at the May 31 FSC meeting.
