

## Request for an Appeal Hearing with the Senate Governance Committee

### TYPE OF APPEAL (select one)

Students may appeal the decision of the Final Grade Appeal Committee only on the basis of alleged unfairness or bias in the process of the Final Grade Appeal, as stipulated in the Final Grade Appeal (217) Policy.

Students may appeal the Dean or designate's decision within ten business days of receiving the decision, if they can provide evidence of procedural bias or unfairness, or if the assigned penalty falls under 7.4 (in the procedures for Student Academic Misconduct (70) Policy).

Students may appeal determinations of a suspension or expulsion, as stipulated in the Safe Student Learning Community (204) Policy.
